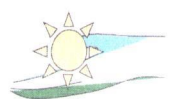

The successful tenderer is not subject to restrictive measures as defined in the procurement documents, has access to procurement and is not excluded under Article 138 or rejected under Article 143 of the Financial Regulation. The tenderer meets the selection criteria specified in the procurement documents and is not subject to conflicting interests which may negatively affect the performance of the contract. Its tender complies with the minimum requirements specified in the procurement documents and has been ranked first as the most economically advantageous tender based **on the lowest price award method.**

To earmark **€748.518,00** as the budget ceiling for the performance of the resulting contract, covering a maximum of **six months** from the date of entry into force.

Explanation

The previous decision on the selection of the most advantageous bid was subject to an appeal procedure initiated by **LTD Energy Systeme**. As a result of this appeal, the **Evaluation Committee** decided to return the procedure to the evaluation phase for a reassessment of the complainant's bid.

In compliance with this decision, the **Evaluation Committee** conducted a new evaluation, limited exclusively to the bid submitted by **LTD Energy Systeme**, ensuring adherence to all relevant criteria and regulations in accordance with PRAG. After a detailed review, it was confirmed that the results of the previous evaluation remain unchanged. Due to non-conformance, the offer submitted by **LTD Energy Systeme** could not advance to the financial evaluation stage.

This decision replaces the previous selection decision and reflects the final status following the reassessment. This ensures transparency and legal certainty in the procedure.
